The threat makes no sense as they were paid by the taxpayer for that report. When they handed it over to the Bitou Municipality, it became public property. At no stage have i claimed that i received it from a Mazar's employee and i emphatically state that i didn't. Notably, they never asked me who i gained it from.

Is Mazar's acting on their own or at the behest of the Democratic Alliance or Bitou Municipality? That important question is unlikely to be answered but the consequence, personally, is that i will never be able to trust Mazars.

Even when exposed, there's no investigation or punishment, only cover-up. Instead, i've been taken to court many times, the DA attempting to bury my whistle-blowing and destroy my life.**
